# Group of composers processes PRS for Music for authors' rights in the United Kingdom

A group of composers, including Jim and William Reid of the Jesus and Mary Chain and Robert Fripp of King Crimson, has filed a lawsuit against the PRS for Music, a UK entity responsible for the management of authors' rights, claiming that the organization charges excessive administrative taxes and offers preferential deals to successful composers. The PRS for Music acts as an intermediary between companies that play music and the writers, collecting licensing taxes and distributing the royalties to the composers. However, the legal process alleges that the PRS offers "hand-drawn deals" to successful composers, while imposing excessive taxes and bureaucracy on smaller composers who wish to withdraw from the organization and license their music directly with promoters, local venues and festivals.

## Table of administrative taxes of the PRS for Music

### Composer level Administrative tax

Major composers 0.2%

Other composers 23%

The lawsuit is led by Pace Rights Management, a company that offers direct licensing of authors' rights for live performances. Pace was founded by artists' managers who are critical of the PRS system.

The PRS for Music issued a statement to the press saying it "will vigorously defend the organization against these allegations". In the UK, the royalties of live performance composers represent 4.2% of the gross ticket price (compared to 3% until 2024). The PRS usually charges an administrative tax of 23% on these royalties before paying the relevant composers.
